Dear Mayor Smith:

Kenneth N. Beth, of the firm of Evans, Froehlich, Beth & Chamley, agrees to provide the Village of Rantoul (the "Village") with certain legal services and representation as its Village Attorney. The purpose of this letter is to confirm the terms on which I propose to be retained by the Village as its Village Attorney effective as of July 1, 2017.

As Village Attorney, I will continue to provide the legal services and certain related expenses and costs as outlined below for a retainer fee of \$3,000 per month. This retainer fee includes: (i) preparation for and attendance at all regular and study session meetings of the President and Board of Trustees, including the review of agendas and routine legislative actions; (ii) furnishing general legal advice to elected and appointed Village officials on an as-needed basis; (iii) communications with the news media, the public and Village Court defendants, as required; (iv) review of new legislation and court decisions affecting the Village; and (v) certain routine costs and expenses incurred in performing these and other services including first-class mailings, photocopying, computerized research, travel within Champaign County and long distance telephone and faxing.

Kenneth N. Beth will be the partner who will have primary responsibility in this matter, but I may be assisted by other lawyers of our firm, if needed. Mr. Beth's services other than those described above are billed at the rate of \$185.00 per hour for all services as Village Attorney, except for any services related to tax increment financing and other economic development matters which are billed at the rate of \$275.00 per hour. Any services provided as Bond Counsel are expressly excluded from any such hourly rates and will be billed on a flat fee transactional basis for each financing.

In addition to my fees, the firm will be entitled to payment or reimbursements for extraordinary costs and expenses incurred in performing legal services including, but not limited to, any mass mailings, overnight delivery services, travel to locations outside Champaign County (including mileage, parking, lodging and meals, if applicable), court costs, filing fees, court reporting fees and recording fees. Unless special arrangements are made at the outset, fees and expenses of others will not be paid by our firm and will be the responsibility of, and billed directly to, the Village.

It is difficult, if not impossible, to predict with any degree of certainty the total fees and costs that will be incurred. Factors and circumstances beyond my control affect the cost of the legal services I am providing. However, I and our firm will use our best efforts to maximize our efficiency and minimize the Village's costs.

I will send monthly, detailed billings that are payable upon receipt. Such billings will include all legal fees incurred and will detail any costs or expenses that have been advanced on behalf of the Village. In some instances, expenses may also be submitted directly to the Village for payment and will not be advanced by our firm.

You shall have the right at any time to terminate the services and representation of me and our firm upon written notice to our firm. Such termination shall not, however, relieve the Village of the obligation to pay for all services rendered and costs or expenses paid or incurred on behalf of the Village prior to the date of such termination.

If the foregoing correctly reflects your understanding of the terms and conditions of my representation, please indicate acceptance by executing the enclosed copy of this letter in the space provided below and return it to our office.

AN ORDINANCE SUPPLEMENTING AND AMENDING CHAPTER 38 OF THE RANTOUL CODE BY ADDING A NEW SECTION 38-296 IN CONNECTION WITH LOW-SPEED BICYCLES

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, ILLINOIS, as follows:

<u>Section 1.</u> <u>Supplement and Amendment.</u> That ARTICLE XII, entitled "BICYCLES, SKATEBOARDS AND SKATES", of Chapter 38, entitled "TRAFFIC AND VEHICLES", of the Rantoul Code, as supplemented and amended, be and the same is hereby further supplemented and amended by adding a new Section 38-296 to be entitled, "Low-Speed Bicycles" to provide as follows:

Sec. 38-296. - Low-Speed Bicycles.

It shall be unlawful and a violation of this section for any person to operate a low-speed electric bicycle or low-speed gas bicycle on any public sidewalk, bicycle path, multi-purpose path or trail within the village, except when any such bicycle is being propelled exclusively by human power.

<u>Section 2</u>. <u>Effective Date</u>. This Ordinance shall become effective following its passage, approval and publication as required by law.

This ordinance is hereby passed, the "ayes" and "nays" being called, by the concurrence of a majority of the members of the Corporate Authorities then holding office at a regular meeting on the date set forth below.

AN ORDINANCE IMPOSING A MORATORIUM ON ALL ACTIONS UNDER THE RANTOUL ZONING ORDINANCE

WHEREAS, the Village of Rantoul, Champaign County, Illinois (the "Village") is a home rule unit under and pursuant to Section 6(a) of Article VII of the Constitution of the State of Illinois, and is authorized to exercise any power and perform any function pertaining to its government and affairs, including the power to regulate zoning within the corporate limits of the Village in such manner as the President and the Board of Trustees (the "Corporate Authorities") of the Village may authorize; and

WHEREAS, the Corporate Authorities of the Village have determined that it is advantageous and desirable for municipal purposes and the public welfare of its residents for the Village to update and revise the Rantoul Zoning Ordinance, including the related official zoning map (the "Zoning Map"), in order to promote and protect the health, safety, morals and welfare of the public to the end that adequate light, pure air and safety from fire and other dangers may be secured, that the taxable value of land and buildings throughout the Village may be conserved, that congestion in the public streets may be lessened or avoided, that the hazards to persons and damage to property resulting from the accumulation or runoff of storm or flood waters may be lessened or avoided, and to insure and facilitate the preservation of sites, areas and structures of historical, architectural and aesthetic importance; and

WHEREAS, certain comprehensive text amendments to the Rantoul Zoning Ordinance together with certain amendments to the related Zoning Map have been filed with the Planning and Zoning Commission of the Village and notice of the public hearings to be held by the Planning and Zoning Commission at its meetings commencing on July 24, 2017 and from time to time thereafter have been or will be published and mailed in accordance with applicable law; and

WHEREAS, the process of conducting the required public hearings considering those certain comprehensive text amendments to the Rantoul Zoning Ordinance together with those certain related amendments to the Zoning Map is reasonably expected to take up to <u>six</u> months prior to the adoption thereof by the Corporate Authorities, during which time there needs to be certainty in the comprehensive text and Zoning Map amendments to the revised Rantoul Zoning Ordinance under consideration.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, ILLINOIS, as follows:

- <u>Section 1</u>. The Corporate Authorities hereby impose a moratorium for up to six months upon any other text amendments or zoning map amendments to the Rantoul Zoning Ordinance as well as upon the issuance of any variances or special use permits thereunder.
- <u>Section 2</u>. That all ordinances or parts of ordinances in conflict with or inconsistent with the provisions of this ordinance are hereby superseded to the extent of such conflict or inconsistency.

<u>Section 3</u>. The provisions of this Ordinance shall become effective immediately following its passage, approval and publication as required by law.

<u>Section 4</u>. The Village Clerk is hereby authorized and directed to cause this ordinance to be published in pamphlet form.

That the Corporate Authorities of the Village hereby expressly find and determine that: (1) confidentiality still exists in connection with those Confidential Closed Meeting Minutes designated by an "X" in the column under the heading "Confidentiality Still Exists", and (2) confidential treatment is no longer required in connection with those Confidential Closed Meeting Minutes designated by an "X" in the column "To Be Made Available" in that it is no longer necessary to protect the public interest or the privacy of an individual by keeping them confidential.

<u>Section 2</u>. That the Village Clerk shall make those Confidential Closed Meeting Minutes so designated by an "X" in the column "To Be Made Available", if any, available for public inspection.
