The Finance Manager is ultimately is responsible for employee payroll, IMRF reporting, and for managing employee and employer contributions to IMRF. With the departure of the current IMRF Authorized Agent, it seems an opportune time to move the duties of the IMRF Authorized Agent under the purview of the Finance Manager. This action would become effective on 6/20/2018.
