ORDINANCE NO. 2359

AN ORDINANCE
ANNEXING CERTAIN TERRITORY TO THE
VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS
(VILLAGE-OWNED TERRITORY)

WHEREAS, the territory hereinafter described is owned by the Village of Rantoul, Champaign County, Illinois, (the "Village"); and

WHEREAS, there are no electors residing within such territory; and

WHEREAS, such territory is not within the corporate limits of any municipality but is contiguous to the Village; and

WHEREAS, no legal notices regarding the intention of the Village to annex such territory have been sent to any public bodies required to receive such notice under the laws of the State of Illinois, it having been determined that such territory to be annexed is not a part of any Fire Protection District or any Public Library District and does not include a highway under the jurisdiction of Rantoul Township; and

WHEREAS, all matters and things necessary to annex such territory are in full compliance with the laws of the State of Illinois, including in particular Section 7-1-9 of the Illinois Municipal Code (65 ILCS 5/7-1-9); and

WHEREAS, it is in the best interests of the Village that such territory be annexed to the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. That the following described territory:

(See Plat of Annexation attached hereto and made a part hereof),

together with any adjacent highway or part thereof to the far side of any such highway is hereby annexed to the Village of Rantoul, Champaign County, Illinois.

Section 2. That the Village Clerk is hereby directed to record with the Recorder of Champaign County, Illinois and to file with the County Clerk of Champaign County, Illinois, a certified copy of this Ordinance, together with an accurate map of the territory annexed.

Section 3. That the Village Clerk is hereby further directed to send by registered or certified mail a copy of this Ordinance to the County Clerk as the election authority having jurisdiction of such territory and to the post office branch serving such territory.


Section 4. That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
