ORDINANCE NO. 2461

AN ORDINANCE
AMENDING SECTION 2-20 OF THE
CODE OF ORDINANCES, VILLAGE OF RANTOUL, ILLINOIS IN
CONNECTION WITH THE TIME OF STUDY SESSION AND REGULAR MEETINGS

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. Adoption. That Section 2-20, entitled "Regular and special meetings, study sessions", of ARTICLE II, entitled "BOARD OF TRUSTEES", of Chapter 2, entitled Administration, of the Code of Ordinances, Village of Rantoul, Illinois, as supplemented and amended, be and the same is hereby further supplemented and amended to provide as follows:

ARTICLE II. - BOARD OF TRUSTEES

Sec. 2-20. - Regular and special meetings; study sessions.

- (a) *Place.* all regular meetings and study sessions of the board shall be held in the Village Board Room, Municipal Building, Rantoul, Illinois, or at any other place within the village the president and board may designate.
- (b) *Time.* Unless otherwise specified by the president and the board of trustees, regular meetings and study sessions shall be held at 6:00 p.m. on the date specified.
- (c) *Regular meetings.* Regular monthly board meetings shall be held on the second Tuesday of each month, provided that if said Tuesday shall fall on a legal holiday then the regular meeting shall be held on the day following.
- (d) *Study sessions.* A study session shall be held on the first Tuesday of each month, provided that if such Tuesday shall fall on a legal holiday the study session shall be held on the day following. The purpose of such study session shall be to discuss departmental matters, review agenda for the regular meeting and to informally discuss municipal business. No formal or final action shall be taken on any matters at any such study session.
- (e) *Special meetings.* Special meetings shall be held as called by the president or by any three trustees. Only those matters described in the notice given may be determined at a special meeting.
- (f) *Adjourned meetings.* Regular and special meetings may be adjourned to any specific time, date and place agreed upon. The agenda for any adjourned meetings shall be limited to the agenda for the regular or special meeting that was adjourned.

Section 2. Effective Date. This Ordinance shall become effective following its passage, approval and publication as required by law.

Section 3. Publication. The Village Clerk is hereby authorized and directed to cause this Ordinance to be published in pamphlet form.

This Ordinance is hereby passed, the "ayes" and "nays" being called, by the concurrence of a majority of the members of the Corporate Authorities then holding office at a regular meeting on the date set forth below.
