

ORDINANCE NO. 2648

**AN ORDINANCE
PROVIDING FOR THE ADDITION OF MAPLEWOOD DRIVE
TO THE MUNICIPAL SYSTEM OF THE VILLAGE OF RANTOUL
CHAMPAIGN COUNTY, ILLINOIS**

WHEREAS, the Village of Rantoul and the County of Champaign, under date of May 12, 2020 entered into an agreement for transfer of jurisdiction of Maplewood Drive from the North Corporate Limit of Rantoul (Mile 0.13 southerly 1.39) to the end of the County Highway designated to the Municipal Street System.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, that Maplewood Drive from the North Corporate Limit of Rantoul (Mile 0.13 southerly 1.39 to the end of the County Highway being a total length of 7339 feet (1.39 miles) in their entirety), be added to the Municipal Street System.

The Village Clerk is directed to forward a certified copy of this Ordinance to the State of Illinois through its Regional Engineer's office at Paris, Illinois
