

ORDINANCE 2778

**AN ORDINANCE
AUTHORIZING THE CONVEYANCE OF PERSONAL
PROPERTY OWNED BY THE VILLAGE OF RANTOUL, ILLINOIS
(Fire Truck)**

WHEREAS, the Village of Rantoul, Champaign County, Illinois (the “**Village**”) is a Home Rule unit under and pursuant to Section 6(a) of Article VII of the Constitution of the State of Illinois, and is authorized to exercise any power, and perform any function pertaining to its government and affairs, including the power to authorize the sale, conversion, conveyance, trade-in, or other disposition (any of which is collectively referred to herein as a “**conveyance**”), of any of its personal property; and,

WHEREAS, Section 14-106 of the Village Code authorizes the sale or disposition of surplus property valued at more than \$5,000.00 in such manner as the President and the Board of Trustees of the Village (the “**Corporate Authorities**”) may authorize, with or without advertising or competitive bid for any such conveyance; and

WHEREAS, the Village owns an item of personal property consisting of a 2018 Pierce Tender (the “**Personal Property**”), which the Corporate Authorities find has an estimated value of more than \$5,000.00, but is or will be no longer necessary or useful to, or in the best interests of, the Village to retain; and

WHEREAS, the Village obtained an appraisal of the Personal Property, which valued it at between \$185,000.00 and \$190,000.00; and,

WHEREAS, the Village has received an offer from the Ludlow Fire Protection District to purchase such Personal Property for an amount in excess of the appraised value, being \$195,000.00; and,

WHEREAS, the Corporate Authorities believe it is in the best interests of the Village to sell the Personal Property to Ludlow Fire Protection District for \$195,000.00. The two parties also agree that if, for any reason, Ludlow Fire Protection District were to sell the 2018 Pierce Tender, the Village of Rantoul will have first right of refusal to purchase.


NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. The Purchase Offer of Ludlow Fire Protection District as described above is hereby accepted, and the sale of the Personal Property is hereby authorized to be made to Ludlow Fire Protection District in the amount of \$195,000.00.

Section 2. From and after the effective date of this Ordinance, the proper officers, employees, and agents of the Village are hereby authorized, empowered, and directed to do all such acts and things, and to execute and deliver all documents and instruments as may be necessary, to complete the conveyance of such Personal Property, and to carry out the intent and accomplish the purposes of this Ordinance in accordance with its terms.

Section 3. This Ordinance is hereby passed, the “ayes” and “nays” being called, by the concurrence of a majority of the members of the Corporate Authorities then holding office at a regular meeting on the date set forth below.
